An incident is reported under 'damage - offender accommodation/cell' when there is damage (including fire damage) to a cell, detention unit or other offender accommodation which requires immediate reportate (ie. accommodation is unsuitable until repairs are complete).

An incident is reported under 'damage - office/ building' when there is damage (including fire damage) to an office or building, other than offender accommodation, irrespective of how the damage is sustained.

An incident is reported under 'damage - property' when there is damage (including fire damage) to property irrespective of the ownership of the property.

An incident is reported under 'Major Disturbance - Violent Demonstration' when three or more persons are involved in a violent demonstration which challenges the good order and discipline of the facility or other QCS Property.
