


## Instructions to access TrueCrypt encrypted `.tc' files:

- 2. Please request this password via email to EEEU staff at `SCOC EEEU FARNET' and include the job number for example <u>`FR893456'</u> FR 1087002
- 3. Make sure TrueCrypt version 7 is installed on the computer. Any other versions do not work.
- 4. If not installed download this file from the Internet at <a href="http://www.truecrypt.org/downloads">http://www.truecrypt.org/downloads</a>, if the truecrypt exe file is not included on the reports DVD.
- 5. Please obtain assistance from your IT Support staff if you cannot install this application.
- 6. Once TrueCrypt is installed and you have received the password, the `.tc' file can now be opened.
- 7. Double click on the `.tc' file.




8. You will get the following screen:




- 9. Make sure a drive letter is selected which is still available for example 'T:'

- 11. You will get the following screen and asked to type in the password




12. Type in the password and press the 'OK' button.
