4. The accused refused. The vehicle was then seized and driven to the Cleveland Police Station holding yard. (Truman's paras 61-72).
5. Constable Truman made arrangements for Detective Dobbie and Sergeant Schnitzerling to conduct a re-enactment. (Truman para 76).
6. On 8 November 2012 Detective Dobbie attended the Cleveland property point, obtained the keys to the vehicle and removed it for the purposes of the re-enactment.
7. Dobbie then drove the vehicle on a public road for the purposes of the re-enactment.
8. Schnitzerling observed the re-enactment.

Unlawfulness

9. None of the police officers involved in this investigation:-
 - (a) Were authorised to do other than search the vehicle at an appropriate facility for searching the vehicle; and
 - (b) Were authorised by the accused to drive the vehicle.
10. The usage of the vehicle for the purposes of the enactment was unlawful.

Discretion

11. There remains the discretion to allow the admission of the evidence:

Bunning v. Cross 141 CLR 54.

50. The evidence should be excluded.

The Record of Interview with the accused 18/10/12

51. The interview from p. 89/40 onwards should be excluded.

52. The accused was cross examined by Officer Truman.

Unlawfulness

9. None of the police officers involved in this investigation:-

 - (b) Were authorised by the accused to drive the vehicle.
