

## Incident 138613 - 19 May 14

**Incident Location** Wolston Correctional Centre

**Description** At approximately 1430hrs, Residential Movement Control officer advised Master Control that there was what appeared to be a craft or drone flying behind Zone 5 (rear of Residential), and for the CCTV camera's to scan over that area.

### General

**Cause**

1. At approximately 1523hrs, it was confirmed by QPS CERT Officer Shaun TANSLEY, that the craft was a Fixed Wing UAV under their control.

**Action Taken**

1. PRV and Delta Unit deployed. PRV also carried out continous patrols of the perimeter, with nothing to report.
2. No prisoner movement called and also no vehicle movement.
3. Mt Omaney Police contacted and later advised the details of Sargent Tansley.
4. Brisbane Womens CC notified.
5. Intel Advisor and Anaylst investigate by foot - Nothing to report.

**Further Action**

1. Seargent Shaun Tansley - QPS CERT training facility confirmed that the craft (Fixed Wing UAV) was under their control. Sargent Tansley was then advised that any further operations of such are to be communicated through to the GM and AGM of WCC and BWCC and that no craft to fly anywhere near the vacinity of either Centre.
2. Officer reports to be furnished and attached to incident.

**Comments** For note - as attached to this incident report - CCO Peter WILLIAMSON noticed model aircraft being flown the previous day at a location further down Grindle Road. Whilst the centre were unsure of the observed drone / craft near the fence line, this information became pertinent was used to investigate an option.
