I confirm that Morgan Lane and I were appointed liquidators of Kar Land Pty Ltd on 27 July 2012 under Part 5.5 of the *Corporations Act*.

By virtue of my appointment, Section 506 of the *Corporations Act* empowers me to realise any company property (including motor vehicles stock) for the benefit of creditors. At present, my office is working to the following matters;

- · Securing and realisation of any physical assets
- Collections of records of the company

In these early stages of the liquidation, my office has been inundated with telephone calls and electronic mail type communications. My staff is making a concerted effort to return all communications in a timely fashion, however given the large quantum of enquiries received, I apologise if there is a delay in returning contact.

I understand at this time that you, and the majority of other customers, have experienced the following:



- An agreement was entered into with the Company to sell a motor vehicle(s).
- The agreed monetary settlement terms were ten (10) days from the date of settlement.
- Payment has not been made to date.

The sale document expressly states 'I/We have this day sold the vehicle described above to the Motor Dealer together with all accessories (as listed), tyres, radio, tools, etc for the sum of \$......(inclusive of GST)'.



The sale documents executed by you have the effect of transferring title of your motor vehicle to the Company as at the date the document was signed. The terms of payment also have the effect of you becoming a creditor of the company in relation to the amount still owed to you.

Unfortunately you do not have any right to repossess or take back the vehicle you sold as the sale

Further, registrations under the new *Personal Property Securities Act* (PPS) are also generally not valid in these circumstances. The sale agreement does not provide for any security or terms of retention of title. Further, a seller's interest would ordinarily need to be registered on the PPS Register prior to the sale in order for it to be valid. Any registrations recorded after the sale date would be considered null and void, and therefore not enforceable

Now that the company is in liquidation, you will be ranked as a <u>non-priority unsecured creditor</u> in the liquidation.
