

Motor dealer collapse sparks lengthy investigation

THE financial arrangements of collapsed high-profile second-hand motor dealer We Buy Any Car could take six months to work through, the administrator has warned.

And forensic accountants Worrells partner Raj Khatri said the company's debts, two weeks after the collapse, had risen to \$12 million, "and could go much higher". Mr Khatri said it was concerning that the company had fallen so deeply into debt only 12 months after it was launched.

"Millions of dollars appear to have flowed out of the company," he said.

"Its books are in a very poor state, and it will take quite a time to track down where the money has gone." Vehicles went missing from the company's Sunshine Coast car yard when the administrator moved in on July 27.

Mr Khatri said the administrators had now confirmed five cars and two motorcycles were missing.

What action might be taken over the missing vehicles was still being examined.
