





## Public Warning on We Buy Any Cars

NSW Fair Trading Commissioner, Rod Stowe, is urging people not to deal with the motor dealer We Buy Any Cars.

Mr Stowe said NSW Fair Trading today issued a public warning under Section 223 of the Australian Consumer Law (NSW).

The company Kar Land Pty Ltd, trading as We Buy Any Cars, operated 3 car yards in the Sydney metropolitan areas of Strathfield, Blacktown and Carlton.

The company's business model is based on obtaining cars from private customers but not paying for the cars until after the cars had been on sold. In many cases, customers were not paid for their cars until many weeks afterwards.

The company also operates in Victoria and Queensland and NSW Fair Trading is working closely with these other jurisdictions.

Fair Trading has received over 100 complaints against the company and is currently finalising a number of enforcement actions to be implemented shortly.

Customers who believe that they are owed money by this business, or who have handed over their cars to the business and have not yet lodged a complaint with Fair Trading, are urged to contact NSW Fair Trading on 13 32 20 as a matter of urgency.

Today we were informed by lawyers acting for that the directors and shareholders of KAR LAND have resolved to place it into a creditor's voluntary liquidation. Inspections on the Mt Gravatt yard confirm the yard has been vacated. QLD OFT's Sunshine Coast office advised on 24 July that the Sunshine Coast 'webuyanycar' yard had closed. The Slack's Creek yard is now under the control of Worrell's Insolvency and they have control of vehicles on site. We'll continue to liaise and provide details of the liquidator..

#### RECOMMENDATION

#### **BACKGROUND SUMMARY**

- 1. Kar Land Pty Ltd (Kar Land) holds a Queensland motor dealers' license which was issued in July 2011 and expires in July 2014. Kar Land's principal place of business is 1339 Logan Road, Mount Gravatt. Kar Land's principal is Mr Richard David John Burbage. He is a director of Kar Land together with Sch4/3/3 Both reside within Queensland.
- 2. Kar Land is trading as 'webuyanycar', utilises the website 'webuyanycar.com.au' and operates four car yards in Queensland, three in New South Wales and two in Victoria. Kar Land advertises on its website seeking to purchase vehicles from consumers, promising payment within 7-10 business days. An expected value of the subject vehicle is provided when consumers enter the vehicle's particulars on the website.
- 3. If consumers are satisfied with the expected value of the vehicle and are seeking a quick sale, they then approach one of Kar Land's car yards to complete the sale process.

#### **ISSUES**

- 4. In April 2012, the Office of Fair Trading (OFT) received several consumer complaints about Kar Land and commenced an investigation. Complainants were concerned they had not received payment for their vehicle and that the eventual negotiated purchase price was always considerably lower than represented on Kar Land's website.
- In June 2012, New South Wales (NSW) Fair Trading and Consumer Affairs Victoria advised they were both dealing with numerous complaints about Kar Land. Accordingly, a multi agency investigation was commenced.
- 6. To date 61 complaints have been received by OFT. 38 initial complainants have since received full restitution to the value of the negotiated sale price. The usual time period for payment to be made to consumers, was 4 6 weeks.

7. On 16 July 2012, 'A Current Affair' featured the company, listing a number of consumers who had not been paid for the sale of their vehicle. The report featured yards in NSW, VIC and QLD. Mr Burbage responded to the article stating that 5200 cars had been purchased with the majority of customers satisfied and any delays were due to the unexpected volume of consumer interest in his services. He further stated that from Monday 20 August 2012, any customer that had not received payment within 10 business days would receive a further 10% of the negotiated sale price.

- 8. On Friday 27 July 2012, Kar Land was placed into voluntary external administration and on 30 July 2012 a resolution to wind up the company was received by the Australian Securities and Investment Commission. Worrells Insolvency has been appointed liquidator. Subsequent inspections of all car yards have confirmed the yards are vacant and no longer trading. The company website has also been withdrawn.
- 9. Worrell's has advised OFT there appears to be in excess of 400 vehicles where title was transferred to Kar Land, however payment has not been made to the vendor. Worrells intends to list any consumers that have not received payment as unsecured creditors. Therefore affected consumers are required to contact the liquidator and lodge a claim. It is unlikely affected consumers will receive full restitution for their vehicles due to the estimated value of the company's assets.
- 10. The investigation has revealed that offences against either the Australian Consumer Law (ACL) or the Property Agents and Motor Dealers Act 2000 (PAMDA) are likely. Where offences against the ACL are prosecuted, OFT is able to make a compensation order application to the court on behalf of consumers. Such an application would only be effective against Mr Burbage and Sch4/3/3 as the company has few assets. The culpability of those individuals is still being assessed however OFT is aware that both hold several properties in Queensland.
- 11. PAMDA establishes a Claim Fund for consumers who suffer financial loss as a result of significant breaches within PAMDA. Preliminary advice indicates in this case payment from the fund is unlikely because of the difficulty in proving that at the time the contracts were entered into, the licensee was unable to complete the transaction. Even if this hurdle were overcome, due to the lawful processes undertaken by Worrells, the most a person is likely to obtain, upon proof of loss, is a negligible amount for lost opportunity such as interest charged on an outstanding loan or similar over the few days between payment being due to the vendor and the appointment of the receiver.
- 12. Therefore it is likely that charges will be taken pursuant to the ACL, with an accompanying compensation order application.

At the outset, I note that you have now served an additional notice ("the Second Notice") to dated 31 July 2012 pursuant s556 of the *Property Agents and Motor Dealers Act* 2000 ("the Act"). That notice requires compliance by 10am on 7 August 2012.


