

Summary:	YP Sch4/3/3 attempted to assaulted YW by punching him in the side of the head.
	YP was removing himself from the top bunk or in an attempt to assault staff he started kicking out at SS and YW YP then began to throw punches in which one grazed YW on the left side of his head, as he lunged at him. Shift Supervisor and YW were in the room and in attempt to support YW as he fell backwards, YP ontinued to lunge and fell on YW landing on his right leg, with pain to the outer or anterior side of the knee.
	YW was in immediate pain trying to dislodge his leg from under YP while at the same time attempting to escape the room as he felt endangered. YP was on his leg whilst Shift Supervisor and SS were trying restrain YP as he was still attempting to assault staff. (Shift Supervisor

Any injuries incurred by staff and YP: Ni injuries to YP S47(3)(b) received an injury to his right knee as a result of YP Sch4/3/Becoming extremely aggressive and assaulting YW causing he and staff to fall to the ground whilst PAC techniques were attempted within the bedroom. (NB: At the time of these review comments being made, YW is still unable to attend duty as a result of this injury,


