A spokesperson said the government was considering a range of supervised bail accommodation options that would give courts more choices to deal with Queensland's youth remand rates which are the highest in the country.

"Approximately 80% of young people in detention centres are on remand. Many are there because they don't have access to secure accommodation when the court considers bail.

"These are youths who are in custody even though they haven't been convicted, but are awaiting court processes.

"Providing supervised bail accommodation alternatives will give courts another option when considering applications for remand or bail to ensure youths will comply with bail and get the assistance they need to stop future offending.

"We want courts to have the option that instead of releasing a young offender on bail to their home address, which may be unsafe or unstable, to send them to one of these supervised bail facilities, where they will be constantly supervised and have to abide by strict conditions.

"When considering a remand alternative the court will need to be satisfied that a young person or others would not be an unacceptable risk if they reside at one of these facilities.

"While the LNP have no policies when it comes to breaking the cycle of youth crime, the Palaszczuk is providing evidence based alternatives to reduce youth offending."

Hi Fiona - responses to questions below.

#### 1. What is the breakdown of the \$199m for moving 17yo offenders from adult prisons?

- This funding, over the next four years, will see Youth Justice partner with other government agencies to provide for:
  - More regional staff to supervise and support 17 year olds on supervised orders (both upon commencement of the new legislation and ongoing),
  - More funding for Legal Aid to represent 17 year olds in court,
  - New, innovative, culturally responsive remand reduction initiatives that will see fewer young people in our detention centres (including alternative options for very young offenders, as well as enhanced bail options)

- Improved court efficiencies, through the appointment of more Childrens Court Magistrates, and
- An increased range of police diversion options
- These options will see the current detention centre population reduce (particularly the younger cohort) so sufficient room can be made to accommodate 17 year olds in detention centres as soon as possible.

### 2. How many 17yo offenders are there in the system currently? When will they all be moved?

- As at 13 June, 49 total 17 year olds were in QCS custody 45 were male, 4 female. This does not include young people in watch house custody.
- Youth Justice intends to utilise a transitional regulation allowed for by the Youth Justice and Other Legislation (inclusion of 17-year-old persons) Amendment Act 2016 to facilitate the transfer. This transfer may occur in a staggered manner however this will occur much quicker than the two-year timeframe that the legislation allows. These 17 year olds will be progressively transitioned to youth justice detention facilities in a safe and managed process following commencement of the new legislation in early November 2017.
- In addition to the 49 seventeen year olds currently in adult prisons, a further 192 seventeen year olds are currently being supervised by Queensland Corrective Services on community based orders. These 17 year olds on community based orders will immediately transfer to supervision by Youth Justice upon commencement of the new legislation.

### 3. Will there need to be new infrastructure built?

- Following evidence and trends by leading jurisdictions, Youth Justice is not considering building a new, large-scale detention centre.
- There are some smaller-scale infrastructure elements being considered by Youth Justice, including bail accommodation services across the State with each catering for a maximum of 12 young people at a time together with a number of small household-type facilities to support the very young cohort closer to their families and communities.


#### 4. Why will the program take four years?

- Youth Justice has been progressing this work since the Amendment Act was passed in November 2016. Youth Justice is working to roll out an initial response in time for the November 2017 transfer of 17 year olds, with additional elements rolled out as soon as practicable following this. The program itself will not take four years to implement but has already been provided with funding for the first four years of operation.
- The government's allocation of four years of funding demonstrates their commitment to longterm, sustainable change.


