Opening and Naming Plaque - new Supreme and District Court

#### RECOMMENDATION

That you **approve** work to proceed for production of the opening and naming plaque with State Coat of Arms at an estimated cost of \$50,000, being \$45,000 plus GST.

#### BACKGROUND SUMMARY

- 1. The Attorney-General recently visited the new Supreme Court and District Court building with the Chief Justice and a proposed plaque design and location was discussed. It was agreed that this proposal would be costed and a brief prepared.
- 2. The plaque consists of three separate parts: the traditional "foundation stone" record of opening; the proposed name of the building; and the large State Coat of Arms see Attachment 1.
- 3. The estimated design, manufacture and installation costs for the three parts are:
  - Foundation stone \$5,500 to \$7,500;
  - Name component \$7,500 to \$9000; and
  - State Coat of Arms \$12,500 to \$15,000.

The estimated total cost, allowing for a 10% contingency and scaffolding for erection, is \$45,000 plus GST.

#### **ISSUES**

- 4. The estimate is based on the use of aluminium which is cheaper than the stainless steel or bronze alternatives. A smaller size plaque was investigated but does not reduce the cost significantly as the aluminium must be purchased in a single sheet the size of which approximates the total plaque size.
- 5. To reduce costs it would be possible to proceed with the foundation plaque and the name and omit the State Coat of Arms.
- 6. The full plaque can be produced in time for the opening on 3 August 2012 if approval is received before 11 June 2012.
