### 5. Next Steps

A preliminary estimated timeline is summarised below:

	Call for proofs of debts prior to issuing notice of intention to declare a dividend
20 April 2021	Issue notice of intention to declare a dividend and call for proofs of debts
11 May 2021	Final day to submit formal proofs of debts
	Formal proof of debt adjudication
24 May 2021	Issue notice admitting or rejecting all or part of formal proof of debt
	Issue notice of request for further evidence in support of formal proof of debt
1 June 2021	Hearing of historical Liquidators' costs
23 June 2021	Issue notice of rejection of formal proof of debt and grounds for that rejection
13 July 2021	Appeal against rejection of formal proof of debt ends
