Purpose: To provide a preliminary overview of the online liquor sales and delivery review project

Background

- In 2020, the Palaszczuk Government committed to consider the efficacy of introducing a regulatory framework governing online alcohol sales and deliveries, in consultation with Retail Drinks Australia (RDA) and key industry and community stakeholders.
- Preliminary research and scoping works have commenced to examine existing legislative obligations and industry standards for the responsible service and delivery of alcohol, both in Queensland and interstate.
- It is anticipated a dedicated consultation process will be initiated in 2022 to seek industry and community views on relevant issues directly with key stakeholders.

Key issues

Preliminary scoping works have identified several issues for further consideration and discussion with key stakeholders during consultation:

Hours for sale and delivery of alcohol

- Impact of rapid and late-night delivery of alcohol into the home on the potential increase of alcohol-related harm.
- Hours for the cessation of home delivery. Research has identified a range of existing limitations and proposals ranging from 10pm to 1am.
- Requirements around same day delivery and non-same day delivery will also need to be resolved.

Third-party delivery service providers

- The duties, obligations and responsibilities of third-party delivery service providers in the online sale and delivery of alcohol in Queensland will need to be examined to ensure appropriate measures for responsible service of alcohol are maintained, such as the refusal of service to minors and unduly intoxicated adults.
- Clarity around the obligations and links between licensees and third-party providers will need to be resolved.

Purpose: To provide an update on the Casino Control and Other Legislation Amendment Bill 2022

Background

- The Casino Control and Other Legislation Amendment Bill 2022 (the Bill) was introduced into Parliament on 26 May 2022.
- The Bill's primary objectives are to:
 - a) strengthen casino integrity and regulation by imposing new requirements on casino entities and their associates to make them more accountable, increasing key penalties for misconduct and breaches of the law, increasing the disciplinary actions that may be taken against casino entities, and expanding regulatory powers
 - b) modernise gambling legislation to improve each gambling Act's capacity to address and respond to emerging cashless payment methods and technologies for gambling by:
 - allowing alternative payment methods to be considered and approved for use in the gambling environment in lieu of traditional forms of payment
 - ensuring that cashless systems and technologies can be made to undergo technical evaluation and be approved (with conditions if necessary)
 - providing a regulation making power dealing with the methods of payment that may be used in connection with a gambling activity
 - providing a regulation making power to prescribe mandatory harm minimisation measures; and
 - providing the chief executive with the ability to issue guidelines about the attitude the chief executive is likely to adopt on a matter, or how an Act will be administered
 - c) expand the existing wagering framework to allow for ministerial consideration and approval of submissions by the sports wagering licensee under the Wagering Act 1998 (Wagering Act) to conduct wagering on certain simulated events and contingencies; and
 - d) extend New Year's Eve gaming hours until 2am on New Year's Day to align with liquor trading hours.
- The parliamentary Legal Affairs and Safety Committee has recommended that the Bill be passed. Debate of the Bill is anticipated shortly.



Key issues

 Subject to passage and assent of the Bill, a number of activities will need to be undertaken to facilitate successful implementation of the reforms.

Amendments relating to casino integrity

- The Office of Liquor and Gaming Regulation (OLGR) will develop internal guidelines in relation to the recovery of disciplinary costs.
- Casino operators will need to consider whether any changes to internal control systems are required, in consultation with OLGR.

Amendments to modernise gambling legislation

- OLGR will communicate with industry on the key changes. The communication will highlight that proposed cashless payment methods or technologies must be submitted for approval by the Commissioner/Chief Executive.
- In the majority of cases, the amendments modernising gambling legislation will commence on assent. However, certain amendments to the Casino Control Act 1982 in respect of cashless payment methods will commence by proclamation. The date of commencement for these amendments will be communicated to casino operators in due course.
- OLGR will shortly be consulting with industry including licensed monitoring operators, gaming
 machine manufacturers, casinos and digital wallet providers, and other relevant stakeholders on
 a new guideline in relation to digital payment platforms for gaming machines. It is intended the
 guideline will include information about the functionalities expected of digital payment platforms.
- Industry will be consulted if any harm minimisation measures, or methods of payment are proposed to be regulated by subordination legislation. No regulations currently proposed.

Amendments relating to wagering on simulated events and contingencies

 The amendments will commence by proclamation. Once commenced, Tabcorp, as the sole sports wagering licensee under the Wagering Act, may make a submission for wagering on simulated events and contingencies (including any associated rule changes and regulated wagering equipment for evaluation and approval). Additionally, the sports wagering licence will need to be returned for amendment to extend the authority of the licence.

Amendments extending New Year's Eve gaming hours

- OLGR will communicate the change to the gaming hours to gaming machine licensees and licensed monitoring operators.
- No further action is required from industry.

Purpose: To provide members with an update on cashless gaming and a renewed approach to liquor availability in restricted communities.

Background

 Cashless gaming and a renewed approach to liquor availability in restricted communities are two priority pieces currently underway.

Key issues

Transition to safe cashless gaming

- A transition to safe cashless gaming in Queensland is a Government Election Commitment.
- The Casino Control and Other Legislation Amendment Bill 2022 was introduced into Parliament in May 2022. Amongst other things, the Bill modernises gaming legislation to facilitate a safe transition to cashless gaming in Queensland.
- OLGR is finalising an initial draft of the guidelines for consultation. The guideline is intended to
 provide guidance to manufacturers and operators and to provide public confidence in a
 transition to cashless payment technology.
- The guideline will outline the consumer protection features expected of the new cashless payment technology, its required functionality and security features as well as how it will interface with external systems.
- To offset any potential for harms from cashless transactions, the draft guideline will require the technology to include the following features: customer verification, limit setting, self-initiated breaks in play or exclusion and friction points for players before they commit to gaming funds transfers.
- Other options may include deposits being subject to configured time delays or require proximity away from gaming machines and quarantining of wins so they can be cashed out but not readily reinvested.
- OLGR proposes to engage with a broad range of industry and community stakeholders to further refine the guideline before release.

Renewed approach to liquor policy in indigenous communities

- The Government has adopted a revised approach to the management of liquor in restricted communities.
- Alcohol Management Plans (AMPs) operate in 19 remote and discrete Aboriginal and Torres Strait Islander communities across Queensland. Areas subject to an AMP have liquor carriage limits prescribed by regulation.

- Since mid-2019 the government has taken a renewed approach to alcohol management in these
 communities which allows for restrictions to be influenced and controlled locally. Amendments to the
 liquor regulation and associated licensing matters to deliver on agreed changes to carriage limits are
 the remit of Liquor, Gaming and Fair Trading.
- A number of communities have recently been granted changes to carriage limits since the approach was introduced and a number of other applications are under consideration.
- Recently licensed premises in these regions include:

Mornington Island

- The liquor regulation was amended in April 2022 to support a change to the carriage limit to allow up to 12 cans of mid strength liquor (up to 4% alcohol by volume)
- A liquor licence was issued for a storage facility known as 'The Barge Shed', and a liquor permit was issued for a community bus, to lawfully transport community members and their liquor from the storage facility to their residential address

Kowanyama

- The liquor regulation amended in April 2022 to support a change to the carriage limit to allow up to 12 cans of mid strength liquor (up to 4% alcohol by volume) and 2 litres of wine
- A community club liquor licence was issued to the Kowanyama Sport and Recreation Association Inc. The licence is heavily conditioned and restricts the sale of liquor for on and off premises consumption in accordance with the revised carriage limit.

Lockhart River

- In March 2022 a restricted liquor permit was approved for the Lockhart River Social Club
 Aboriginal Corporation, which allows liquor to be sold and supplied for consumption on the
 club premises to members and guests of members, while in the members' company.
- The sale of takeaway liquor is not permitted from the premises, and on-premises sales are restricted in terms of liquor strength and the number of drinks available to an individual on a daily basis.

Purpose: To provide an update on OLGR compliance priorities.

Background

 OLGR's compliance division comprises of 13 Offices across Queensland including an onsite presence at each of Queensland's four casinos.

Key issues

Liquor Accord Refresh

- OLGR recently updated its online resources for liquor accords to promote venues 'reconnecting'
 with their local accord or starting an accord in areas where none exist. Benefits of local liquor
 accords are also highlighted by licensees in a short video.
- The online resources include tips and template documents to assist the more than 55 liquor
 accords with ongoing strategies and management of their accord, and an interactive map which
 identifies liquor accord areas, safe night precincts, the location of OLGR's local offices,
 gambling help service networks, and restricted areas (and catchments).

Pub and Club Gaming Machine Harm minimisation and response to money laundering risk

- In 2021 changes were made to OLGR's gaming machine audit program to place a greater emphasis on gambling harm minimisation. Enhancements include OLGR Inspectors engaging with venue leaders and staff to examine key areas of patron observations and management; harm minimisation resources; when the gambling help service is engaged to support harm minimisation programs; safer gaming controls; and corporate oversight of gambling harm minimisation.
- The audit outcome is communicated to the licensee and if necessary, recommendations and
 resources are provided to assist the licensee with strengthening its practices and procedures.
 Findings from these activities have also informed whole of industry communications around
 areas for improvement.
- An internal evaluation of the changes is planned to occur in the next quarter, which will help inform the next phase of enhancements to the program, expected to include more in-depth assessment of gambling harm minimisation measures at risk targeted sample venues. Again, the findings will assist in broader industry awareness raising activities as well as the continual process of program enhancement.
- In response to the risk of money laundering within pubs and clubs, OLGR has enhanced its working relationship with AUSTRAC.
- After releasing its guide for pubs and clubs with gaming machines, AUSTRAC recently undertook training visits to approximately 60 Queensland hotels, pubs and clubs in May 2022,

- visiting greater Brisbane, Gold Coast, Sunshine Coast, Rockhampton, Mackay, Townsville and Cairns. OLGR officers attended many of these sessions.
- Acknowledging that there are some significant similarities in measures to manage gambling harm risk and money laundering risk, AUSTRAC and OLGR are planning some joint initiatives that we'll be able to share with industry in coming months.

External Review of Queensland operations of The Star

- The Queensland Government is determined that Queensland casinos are operated lawfully, ethically and in a way that maintains the highest standards of integrity and public confidence.
- The Honourable Robert Gotterson AO QC has been appointed to lead an external review of the Queensland operations of The Star Entertainment Group Limited (the External Review). Mr Gotterson is being assisted by Mr Jonathan Horton QC.
- As well as considering the operations of The Star's Queensland casinos (Part A), the External Review will:
 - provide advice to inform an ongoing suitability investigation into The Star's Queensland licensees and The Star Entertainment Group Limited's suitability to be associated with the operation of Queensland casinos (Part B); and
 - consider any further improvements to casino procedures, regulations and legislation to enhance integrity, minimise the potential for harm, ensure probity and restore public confidence in casino operations (Part C). This is in addition to amendments to casino legislation currently before parliament.
- The Office of Liquor and Gaming Regulation is supporting the External Review in its inquiries.
- An initial public hearing for the External Review was held on 14 July 2022. Further hearings are scheduled for 23-26 and 29 August 2022.
- Terms of Reference for the review and associated documentation are available online.

 OLGR's Compliance division comprises of 13 offices across Queensland including an onsite presence at each of Queensland's four casinos.

Key issues

OLGR Proactive Compliance Plan 2023-24

- The Liquor and Gambling Regulation Strategy, amongst other actions, makes a commitment to publish an annual compliance plan and report back on progress at the end of each year.
- OLGR's Proactive Compliance Plan 2023-24 (the Compliance Plan) will be a public facing
 document which provides greater visibility to industry of future compliance priorities. It will guide
 compliance assessment activities as well as other regulatory tools targeted to the priority areas,
 such as education and training supports and self-assessment checklists, and will support selfreflection and improvement by industry participants.
- The Compliance Plan:
 - Outlines OLGR's proactive compliance priorities across 2023-24
 - Expands on the principles and approaches which underly the Compliance Plan including:
 - Risk of harm
 - Complaints and compliance history
 - Local issues
 - Information and intelligence
 - Emerging issues and trends
 - OLGR's compliance and enforcement approach.
- Further information on the compliance plan will be communicated in the lead up to its commencement in July 2023.

Gaming guideline G16: Preventing excluded persons entering or remaining on licensed premises

 In October 2022 Gaming guideline G16 was issued by the Commissioner to assist hotel and club licensees and their staff to adopt reasonable steps to prevent excluded patrons from entering or remaining on licensed premises or in a gaming machine area, in line with their obligation under section 261I of the Gaming Machine Act 1991

- The guideline notes organisational leadership and culture in venues should demonstrate that
 profit is not prioritised above the welfare of patrons who may have a gambling problem, and the
 family and broader community who may be impacted because of the individual's gambling
 problem.
- The Guideline sets out a range of foundation measures that every licensee is expected to adopt as well as additional measures that may be adopted for venues that have the necessary resources or an elevated risk gambling harm. It encourages the use of technological solutions, which continue to advance both in effectiveness and affordability.
- Foundation measures include:
 - Registers maintaining registers with appropriate details for staff to detect excluded patrons
 - Procedures and training having appropriate and effective procedures and mechanisms in place with staff trained in the timely, orderly, and sensitive removal of excluded patrons
 - Governance documenting measures to prevent excluded patrons entering or remaining in areas, training staff and sending periodic reminders, reviewing measures to identify improvements
 - IT Systems if in use, effective application of visitor registration systems and card-based play
 - Advertising and promotional activity removal of excluded patrons from any promotional list or social media pages
 - Ongoing monitoring regular monitoring of surveillance systems and physical sweeps of gaming machine areas to assist in both in identifying excluded persons and monitoring for signs of gambling harm; and checking for excluded patrons when transactions occur.
- A reminder around these measures is particularly relevant given recent media coverage of an
 excluded patron allegedly gambling at a venue for an extended period before being refused
 payment of a jackpot win. Amongst other matters, OLGR's investigation will examine the
 venue's operational systems and controls in terms of application of the foundation measures.

Casino Reform

 Casino industry related reforms are a significant priority for OLGR's Compliance division and the agency more broadly, following finalisation of the Gotterson Review and disciplinary actions taken against the Star.

Background

- In line with the Liquor and Gambling Regulatory Strategy, OLGR licensing is continuing to review the way it does business with a focus on timely, efficient and streamlined service delivery.
- Moving to digital first for individual licensing and conducting a review of extended hours permits and are key priorities for the Division.

Key issues

Extended Trading Hours review

- The Summertime Taskforce was established by the Queensland Government as a key election commitment and action under the Big Plans for Small Business Strategy 2021–2023.
- Part of Government's response to the Summertime Taskforce Project Recommendations Report includes delivery of the Queensland Outdoor Activation Action Plan.
- The plan aims to 'support improvements to the small business regulatory and operating environment' through various actions, including:
 - supporting local governments to apply for delegations which allow designated officers to approve a liquor licence change of boundary for outdoor trade subject to certain restrictions; and
 - investigating options to provide greater flexibility for small businesses within the existing extended hours permit framework (as relevant to licensed (liquor) trade between 12am and 5am).
- The extended hours permit provisions allow for one-off extensions to trading hours 6 times a year upon approval.
- The Office of Liquor and Gaming Regulation (OLGR) is leading the review of the extended hours permit framework with a focus on:
 - identifying potential roadblocks for industry under the current administrative system;
 - developing practical process improvements which benefit industry in a way which does not detriment the intent of the legislative framework; and
 - creating transparent guidelines for industry, to ensure greater understanding and utilisation of the permit framework.

- The review is focused on the application process and the criteria outlined in the *Liquor Act 1992*, in particular:
 - persons who are independent of the licensee must seek to celebrate a 'special occasion' on the licensed premises;
 - the extended hours sought must coincide with the special occasion, including a reasonable time before or after; and
 - the special occasion must be a 'unique or infrequent event of local, state or national significance'.
- The review will look at ways to make it easier for licensees to apply for short-term extended hours permits. OLGR expects to finalise the review by the end of April 2023.

Digital first approach

- OLGR is moving towards a 'digital first' approach to modernize and streamline the provision of more efficient licensing services
- In preparation for LGFTs broader IT improvements that will see the range of services available
 to licensee's expanded, OLGR Licensing will be stepping back from accepting hard copy
 applications and encouraging clients to either lodge applications online or electronically. In
 recognition that there are some applicants who will be unable to submit electronically, OLGR will
 continue to accept hard copy applications by exception.
- OLGR online services currently allow applicants and current licensees to manage their liquor and gaming licences online, including submitting the following individual employee licence applications or renewals and paying an outstanding amount
 - liquor approved manager (new and renewal)
 - Gaming nominee (new and renewal)
 - Gaming repairer (new and renewal)
 - Key monitoring employee (new and renewal)
 - Wagering key person (new)
 - Keno employee (new)
 - Lottery key person (new)
 - Casino Employee (new)
 - Casino Key Employee (new)
 - Approved Controller (new and renewal).
- Historically, OLGR has sent renewal reminder notices each month in hard copy to individual licensee's, including gaming nominees, Approved managers, gaming repairers and Key monitoring operators. From April 2023, this will be replaced with an email notification.

Purpose: To provide an update on key liquor and gambling policy priorities.

Background

 The Office of Regulatory Policy (ORP) within the Liquor, Gaming and Fair Trading Division is progressing key gambling harm minimisation projects and liquor and Casino regulatory reforms.

Key issues

Gambling Harm Minimisation Plan

- Implementation of the Gambling Harm Minimisation Plan for Queensland 2021-25 is being coordinated by ORP. Two working groups, including industry, community and government members and an academic with gambling expertise, have been established to support and contribute to implementation of the Plan.
- Key initiatives currently being progressed under the Plan include:
 - Review of the Responsible Gambling Code of Practice and mandatory requirements It is
 anticipated the project will commence at the end of March/early April 2023. A review of
 current requirements against empirical evidence and best practice approaches in other
 Australian and overseas jurisdictions will be conducted. Opportunities to strengthen the
 regulatory framework to deliver stronger harm minimisation outcomes will be identified.
 - Customer care framework for gaming machine environments Development of the framework is being led by Kedron-Wavell Services Club in conjunction with other working party members. The initiative will result in resources and guidance to establish a culture of customer care for different types and sizes of clubs and hotels.
 - Review of Responsible Gambling Networks (RGNets) The aim of this initiative is to
 elevate and connect these networks across the state into harm minimisation policy and
 program development. The initiative includes the development of a toolkit of resources to
 assist Gambling Help services to organise and run effective RGNets.
 - Industry-led multi-venue self-exclusion online database Clubs Queensland and the Queensland Hotels Association are developing a centralised online multi-venue selfexclusion system. The current legislative framework is being examined to identify any impediments to system implementation.
 - Mechanisms for engaging people with lived experience of gambling harm The initiative involves the development of mechanisms to engage lived experience voices meaningfully and safely in Government policy and program development. Principles have been developed and focus group consultation research is currently underway with persons with lived experience to inform the establishment of appropriate mechanisms.
 - Implementing outcomes from the Review of Gambling Help Services An external review identified a range of potential improvements to the service system. In response ORP is

- progressing a range of projects including the development of consistent community education materials, improved online and self-help resources; improved access to non-therapeutic supports; improved aftercare and peer support programs; state supported referral pathways; an outcomes-based framework; and improved use and sharing of data.
- Research project ORP has received funding to conduct research into young Aboriginal and/or Torres Strait Islander males' engagement with online gambling. This will include an examination of the nature of participation in online gambling, factors placing this cohort at greater risk of harm and differences in attitudes and behaviours by geographical location (e.g. rural versus urban communities). The findings from this research will inform the development of effective and targeted interventions.

Queensland Gambling Survey

 Data collection for the Queensland Gambling Survey (formerly the Queensland Household Gambling Survey) will commence in late March 2023 and will provide up-to-date information on the gambling behaviours of Queenslanders. The last survey was conducted in 2016-17. The new survey will include a specific focus on gambling-related harm.

Casino Control Bill 2023

- Further to legislative amendments affecting casinos undertaken in 2022, it is proposed to progress further amendments to implement the remaining recommendations of the Gotterson review.
- These amendments will provide:
 - mandatory carded play with pre-commitment & restrictions on the use of cash for casinos;
 - changing the terminology of gaming Acts to avoid terms like "problem gambler" and "responsible gambling", which discourage help-seeking due to stigmatisation and the suggestion that responsibility for gambling problems resides within the player;
 - requiring casinos to pay a supervisory levy;
 - enhancing police exclusions from casino venues.

Online liquor sales

- In accordance with a Government election commitment, consultation papers are currently being prepared to seek comment from industry and the community on a proposed legislative framework for the online sale and delivery of liquor.
- Key issues will include:
 - Impact of rapid and late-night delivery of alcohol into the home on the potential increase of alcohol-related harm.
 - Hours for the cessation of home delivery. Research has identified a range of existing limitations and proposals ranging from 10pm to 1am.
 - Requirements around same day delivery and non-same day delivery.
 - The duties, obligations and responsibilities of third-party delivery service providers in the online sale and delivery of alcohol in Queensland will need to be examined to ensure appropriate measures for responsible service of alcohol are maintained, such as the refusal of service to minors and unduly intoxicated adults.
 - Clarity around the obligations and links between licensees and third-party providers
- Consultation is expected to be initiated in the first half of 2023.

SNP Review

- Government released Safe Night Out Strategy in 2014 leading to establishment of 15 Safe Night Precincts across Queensland
- In May 2021, findings from an independent study Queensland Alcohol-related violence and Night Time Economy (QUANTEM) revealed a reduction in alcohol-related harm in SNPs
- In response to QUANTEM report, Government made various commitments including a legislative requirement to review each SNP every 3 years to consider whether the SNP is achieving its harm minimisation purposes
- On 1 July 2021 the new provisions commenced committing Government to the review
- In early 2023, OLGR contacted Queensland based suppliers seeking interest in creating an evaluation framework for the review and a procurement process is required to determine the appropriate supplier
- Uploaded to QTenders 16 March 2023. Closing date for applications is 20 April 2023.
- After the evaluation framework is established, it will be necessary for OLGR to undertake a subsequent procurement process to engage an appropriate supplier to conduct the review itself



The LGRG will provide a mechanism for government, key stakeholders, and partners in liquor and gaming industries and the community to come together to discuss challenges and opportunities facing the sector. It will also serve as a platform to positively engage stakeholders in the design, implementation and evaluation of policy and programs.

Draft Terms of Reference for the LGRG, to be discussed and endorsed at the first meeting of the group, are attached for reference. It is proposed the LGRG will meet up to three times each year, with some out of session business as required. Meetings will be held in Brisbane on a date determined in consultation with members, taking account of emerging priorities. The first meeting of the LGRG is intended for Thursday 11 August 2022, 2pm – 4pm.

Given the nature and intent of the group I encourage you to consider a senior nomination for the group if you are unable to participate yourself.
